Background Check and Criminal Denial

In order to protect course participants and students alike, acceptance to the Slingerland Teacher Training course requires satisfactory completion of a criminal background and sex offender registry check.

I solemnly swear that I have not been:

- Convicted of any crime against persons. This means a conviction of any of the following offenses: aggravated murder; first or second degree murder; first or second degree kidnapping; first, second or third degree assault; first, second or third degree rape; first, second or third degree statutory rape; first or second degree manslaughter; first or second degree extortion; indecent liberties; incest; vehicular homicide; first degree promoting prostitution; communication with a minor; unlawful imprisonment; simple assault; sexual exploitation of minors; first or second degree criminal mistreatment; or any of these crimes as they may be renamed in the future.
- Found in any dependency action under RCW 13.34.030 (2) (b) to have sexually assaulted or exploited any minor or to have physically abused any minor;
- Found by a court in a domestic relations proceedings under Title 26 RCW to have sexually abused or exploited any minor or to have physically abused any minor; or
- Found in any disciplinary board final decision to have sexually abused or exploited any minor or to have physically abused any minor.

I understand that an inquiry to the Washington State Patrol, a federal law enforcement agency and/or the WA State OSPI will be made under provisions of RCW 43.43.830. A request for conviction criminal history record (RCW 1097) will be made from the WSP Identification and Criminal History Section and OSPI fingerprint division.
